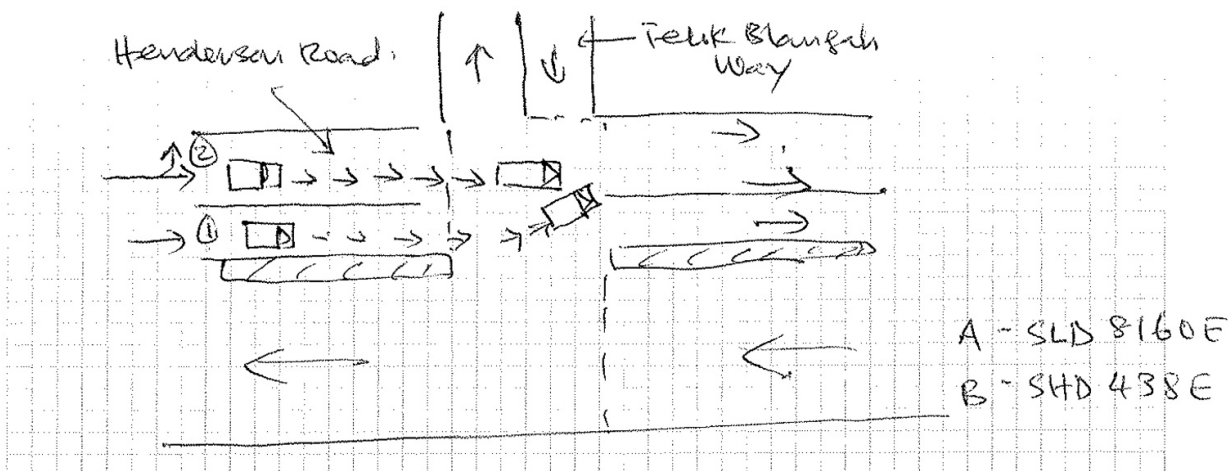

3. If there are witnesses, note down their names, NRIC/FIN numbers, telephone numbers and addresses.
