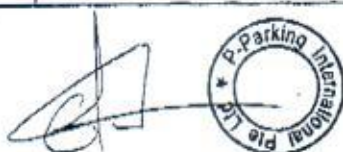

Upon nearing the gantry, I applied the foot brake to slow down to align the vehicle. However, while slowly aligning the STON spare tyre grazed the cash card machine. Causing the cash card machine to be slightly dislodged from the ground. This was due to aligning the STON to the gantry exit which did not have much allowance of space between the STON and cash card machine. Upon nearing the gantry, I applied both hand and foot brakes simultaneously to make sure the vehicle does not roll forwards upon being told to stop by the UCAms. At which I turned off the engine to come down and check. After which I was instructed by WLD Kuanar to reverse according to his ground guide instructions to be clear of the Exit to allow civilian cars to pass by. After which I was instructed by WLD Kuanar to drive back to Camp Subang.</p>
