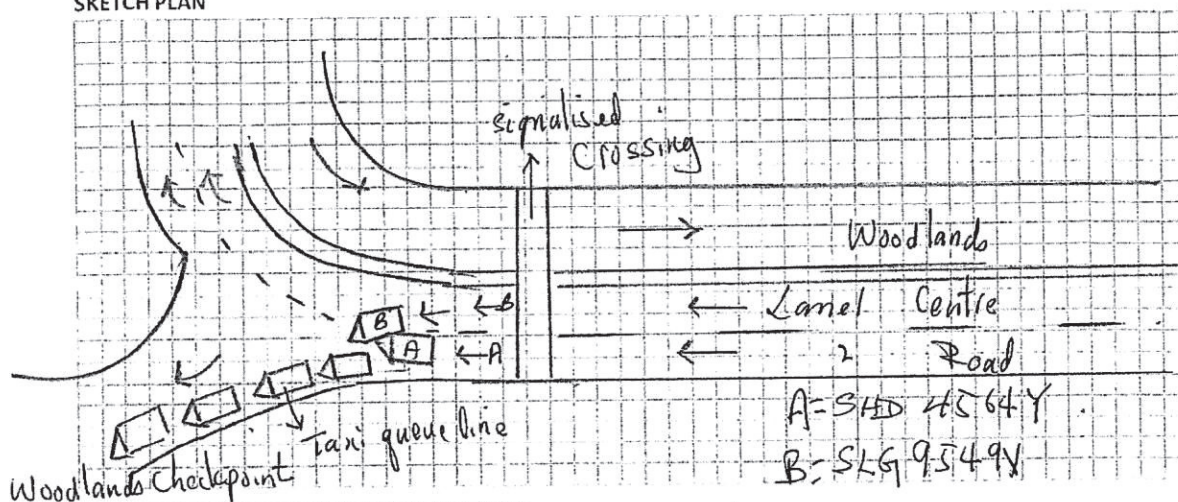

- ACCIDENT STATEMENT

Late into the night on Sunday(26/11/2017), I travelled on Woodlands Centre Road with a female passenger on board my taxi.

I was moving on lane 2 of the 2-lane road as I was nearing Woodlands Immigration Checkpoint.

As seen in the video footage, as I was slowing down the speed further, it was at this juncture car B(SLG 9549X) carelessly cut into my path from lane 1 of the road in order to move into the driveway of the Checkpoint and caused the accident in so doing.

I could not take evasive action when car B cut into my lane just too fast and unexpectedly.

I took photos of car B believed to be a private-hire car following the accident.

While the impact inflicted damage to the right front of my taxi, I found the left rear to car B was dented.

My passenger was not injured.
