Brief Details.

- 1) Driving on a slow traffic road along Thomson Road. Suddenly felt car body was hit somewhere. (Speed: <25km/h)
- 2) Passenger (mother) next to me shouted that my left side mirror was hit and dropped. Was on 2nd lane and did not notice the stationery car (SFB 262D) on the 3rd lane was out of alignment next to me and hence, my side mirror hit his mirror as I was moving on slowly.
- 3) I got panicked and wanted to avoid the bus on my left (ie in front of that car) thinking that I was too near to them without realising I was very near to the car on the 1st lane then and hit the right car (SKN 4963R).
- 4) Wanted to brake in time to avoid further accident but due to the panic, I depressed the accelerator a little and hit the taxi (SHC 5911C) in front of me on my lane. (Speed: 24km/h)
- 5) As the traffic was quite heavy, the taxi hit another car (SBT 3353H) in front of him as well.
- 6) All involved cars (5 cars including mine) stopped to take down number and particulars. No injury was noticed then.

Accident took place at 10.21am and all settled by 10.55am.
