Brief Details.

On 21/11/2017 at about 1300hrs, I was driving my vehicle SGC4845D along entrance of KJE towards Thomson near to Woodlands. When I was entering the KJE, my vehicle were moving slowly while I checked on the last lane if it was safe to enter. After checking, I then entered into the lane. After entering the lane, suddenly I spotted a lorry (unknown plate number, white colour) right behind me and it was travelling at a high speed. I could not speed up as there were a lorry in front of me.

Therefore I signalled to my right wanting switch to right lane. Before I can switch lane, the lorry behind me collided onto my rear right side. The impact caused my vehicle switched to the right lane. At that point of time, there were one vehicle GBD2436T travelling on the right lane and it collided onto my vehicle. I then lost control of my vehicle and collided onto the center guard railing. The lorry who collided my rear did not stop and drove off.

Ambulance came to the scene. There is in car camera installed in my vehicle. Ambulance conveyed me to KTPH. I suffered fracture on my left arms. Abrasion on my face. I was issued 14 days MC. Traffic Police have visited me at the hospital and I have submitted my vehicle recording footage to Traffic Police.
