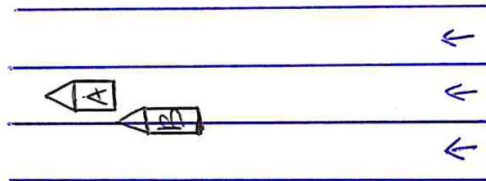


SKETCH PLAN
