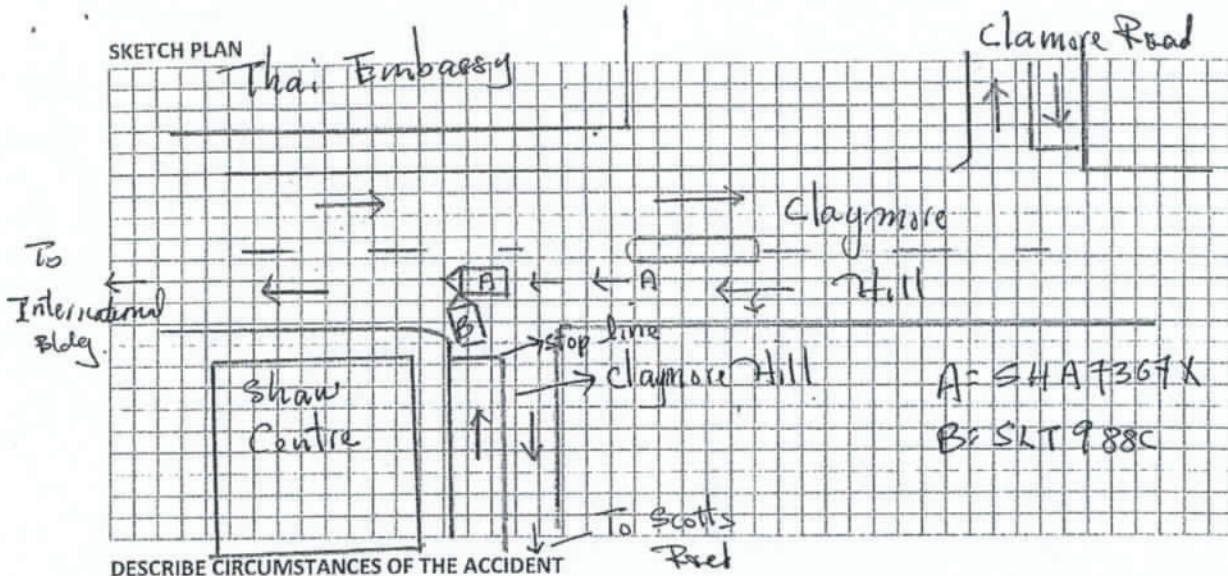

- ACCIDENT STATEMENT

Yesterday afternoon (29/11/2017) I travelled on Claymore Hill with a female Caucasian passenger on board my taxi.

I drove at normal speed on the 2-way road towards International Building which was the destination of my passenger.

As seen in the video footage, while I continued the journey towards the destination, it was car B(SLT 988C) that suddenly hit into my taxi amid exiting the road in front Shaw Centre also called Claymore Hill.

There was a stop line on the side where car B was came from but car B apparently did not stop.

I took photos at the scene following the accident.

The impact inflicted damage to the left front portion of my taxi.

Car B, a Mercedes and driven by a female Chinese, sustained damage to its front right portion.

No report of injury at the time of accident.
