## **Brief Details.**

On 02/11/2017 at about 2030hrs, I was riding my Piaggio Vespa mint green in colour F5416K along the extreme left lane along Seletar West Link. Just when my vehicle was approaching the T-junction of Aerospace Drive, I saw the traffic light at the junction turned Green. I then slowed down my vehicle as I was approaching the junction and I was going straight. However, I noticed that on the middle lane, there are a row of vehicles which was moving off when the traffic light turned Green.

Out of sudden, a Hyundai taxi from the middle lane from the row of vehicles suddenly turned left and cut into my lane and side swipe my vehicle causing me to fall. The taxi driver then stopped his vehicle along Aerospace Drive near to the T-junction and he came out to assist me. I was conscious after the collision but my motorcycle was unable to start. I have exchanged particulars with the taxi driver and also took some photographs of the scene.

I then check the damage on my motorcycle and realized that my motorcycle have sustained the following damages:

- 1) The rim came off;
- 2) Right handle broken;
- 3) Right mirror broken;
- 4) Right signal light broken;
- 5) Right frame broken;

6) ERP unit broken;

7) Engine unable to start.

A passerby saw the accident and assisted to call for ambulance. Shortly after, the Traffic Police and ambulance arrived at the scene. I was conveyed to Khoo Teck Puat Hospital with abrasion on my right palm, my left elbow and both knees and toes. I was then discharged on the 03/11/2017 morning about 0130hrs and was given 3 days MC. While I was in the A&E, I received a call from TP IO Dylan and he advised me to lodge a Traffic Accident Report reference incident F/20171102/0194.

I would like to inform that the Taxi driver has a male passenger at the front passenger seat. However, both of them were not injured. The two left passenger doors of the Taxi sustained some scratches.
