DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

It was around 7:45pm at Kallang Leisure Park carpark. The carpark was dimly lit. I stopped my vehicle A (EB7733C) at the exit of the carpark lane to allow a group of youths to cross.

with the road cleared, The group of youths stopped and signalled for me to cross ahead. ~~As I~~ I released my brake, but just then a black car B (SJS 6680D) was coming very quickly at a ~~side~~ high speed from my right side; its headlamp was unlit.

I stepped on the brake, but my car had scratched his right rear side (SJS 6680D) (passenger side). I also incurred scratches on the centre front left of my car A (EB7733C).

My friend, Goh Li Zhen, S8832081F, who was at the passenger seat also noticed that the car B (SJS 6680D)'s headlamp was unlit at the point of the accident.

In a tele-conversation with the car B's driver, he claimed that my car came to a full stop for him to cross only. I replied that my car came to a full stop for that group of youths. He said ~~at~~ the accident happened, he noticed a group of youths. This further support that his headlamp was unlit as he did not realise that my car had stopped for the group of youths to cross.
