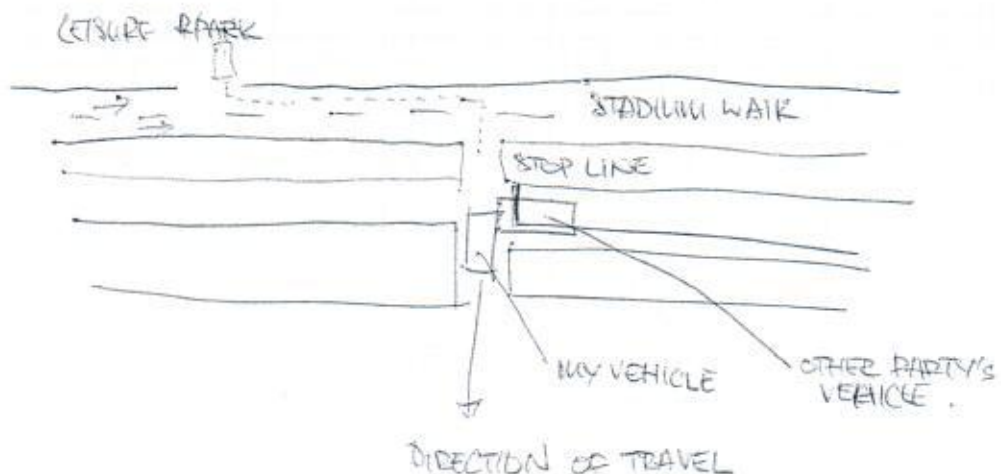

Describe Circumstances of the Accident


On or around 1945HRS on the 1st of Dec 2017, I exited the Leisure Park underground carpark. As I was heading home my ECP towards Telok Kurau, I decided to make a right turn and cut through the car park towards Tanggang Rd, which I frequently do. After making the right turn, I slowed down as I noticed a group of roughly 10-15 youths walking towards Leisure Park on the left hand side of the road. After they shuffled to the back, I proceeded forward. I also noticed the other party's ~~was~~ vehicle to my left. I was aware that it was slowing down. I also would have noticed the stop line ~~at~~ of the other party's ~~at~~ side of the road. Seeing as the other car had slowed down / came to a stop, I continued forward. A few seconds later the rear ~~end~~ left side of my car was impacted, just behind the rear left wheel. From my side and rear view ~~mirror~~ vision, I noticed the car continuing forward after the impact, and hence pressed my car horn for a sustained period of time to draw attention to the individual. The other party continued forward and parked her car at the empty lot immediately next to the junction, and I followed, parking my car beside her.
