**Brief Details.**

ON THE ABOVE MENTIONED DATE AND TIME,

I WAS DRIVING ON PAN ISLAND EXPRESSWAY, ON THE MIDDLE OF 3 LANES. WHEN I PASSED THE STEVENS ROAD EXIT, THE CAR INFRONT OF ME, SLG1431D, SUDDENLY JAMMED BRAKE SO I FOLLOWED AND JAMMED MY BRAKE TOO, I MANAGED TO BRAKE IN TIME, BUT THE CAR BEHIND( SJS9447S), DID NOT STOP AND COLLIDED WITH MY CAR, CAUSING MY VEHICLE TO SURGE FORWARD AND HIT THE VEHICLE INFRONT(SLG1431D) AND CAUSED SLG1431 TO SURGE FORWARD TOO AND HIT THE VEHICLE INFRONT(SJW5337G).

AFTER THE COLLISION, I ALIGHTED FROM MY CAR AND EXCHANGED PARTICULARS WITH THE OTHER DRIVERS UNTIL THE AMBULANCE CAME AND CONVEYED ME AND MY MOTHER TO THE HOSPITAL.
