

CONTINUATION OF REPORT

Brief Details.

On the 03/12/2017 at about 1704hrs, I was driving my Comfort Delgro taxi bearing plate number SHD4513U along the third lane of Seragoon Road. At that time, I had 2 passengers in my taxi. In addition, there was a Mercedes (SKK4061J) behind my taxi and behind the Mercedes was another Comfort Delgro taxi (SHD6799Z). As the traffic volume was high, I was driving at a slow speed.

As I was driving along the said road, passing the junction of Desker Road, I heard a loud bang coming from the back of my vehicle. I then discovered that the taxi, which was behind the Mercedes had collided into the Mercedes rear.

Immediately after the loud bang was heard, I felt an impact from the back. The collision between the Mercedes and the taxi had resulted in the Mercedes to move forward; colliding into the rear of my taxi. After the impact, I checked on my passengers on whether did they sustain any injuries. None of my passengers sustained any injuries.

Subsequently, I alighted my taxi to assess the situation and was assisted by a total of 4 cisco officers who were on patrol. The collision had resulted in the rear of my taxi to sustain minor dents and scratches. The collision was then subsequently attended by 2 traffic police officers. After assessing the situation and exchanging particulars with the other drivers, I then left the location.

During the night of the incident, I suddenly felt stiffness on my neck and back area. As such, on the morning of 03/12/2017, I proceeded to consult a doctor at 'ProHealth Medical Group @ Punggol Damai Pte Ltd' and was given a total of 03 days MC (03/12/2017 - 05/12/2017).
