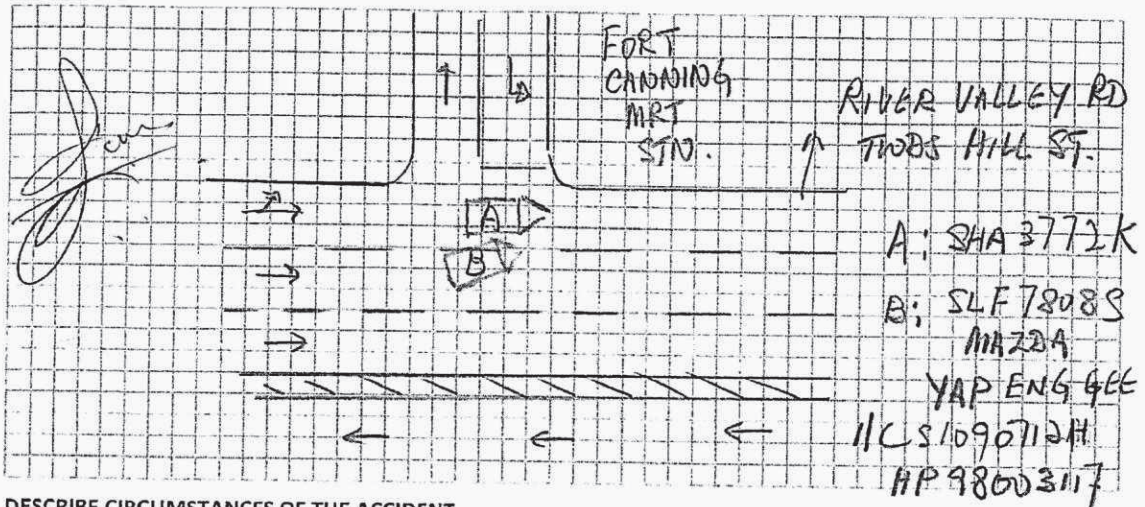

Describe Circumstances of the Accident

On 03 Dec 2017 at about 02:05 hrs the traffic volume was heavy hence the traffic flow was slow moving. Due to this, I was slowly driving on the leftmost lane along River Valley Rd leading towards the direction of Hill St.

Somewhere near Fort Canning MRT station, suddenly a white Mazda car SLF7808S coming from my right cut into my lane. As a result of this, the left hand side front of the car hit and grazed the right hand side front door towards the right hand side rear including the right hand side rear wheel of my taxi thus damaging them in the process.
