CONTINUATION OF REPORT

Brief Details.

On 3/12/2017, at 10.30PM I was driving towards Malaysia Customs, the traffic was heavy and slow moving, upon the merging lane, I felt an impact hit onto my vehicle's right hand position, thus I moved forward and stopped my vehicle. Wanted to get off my stationary vehicle to check what happened, just right before I got out, I felt another greater impact bang onto the rear portion of my vehicle. Both collision were caused by the same car SJE964Z, a black Honda Stream.

I got off after both vehicle stopped, I check there are damages on my rear passenger door and my rear bumper. The other party's driver do not want to get off the vehicle until I told him to get off to check the vehicles. He did not check the vehicle and told me to do my own repairs in a very arrogant manner. I tried getting his particulars but to no available. I cannot do anything but to drive off and make the accident report and police report. The other party's driver looks age of 40s, skinny build and about 1.8m tall.

After the accident, my upper and lower back and my neck were painful, my passengers: my wife and her grandmother also suffered pain on their neck and shoulders on the next morning. We all seek for medical consultation and was given 3 days MC for all of us.

There were 2 kids, 1 infant, 1 elderly and 2 adults in my car when the collision happened.
