Brief Details.

On the 04/12/2017 at about 0005hrs, I was in my vehicle which is a taxi cab (SHC5628X) and was travelling along airport boulevard along the second lane from the right. I was in a line of vehicles waiting to turn into Terminal 2. My vehicle was stationary when another vehicle (SHB8663D) had suddenly collided onto the rear of my vehicle. The impact had pushed my vehicle forward resulting in my vehicle colliding against another vehicle (SHD8566R) which was directly ahead of me. The TP and LTA officers which were at scene had attended to my incident. My vehicle had suffered serious damages to the rear.
