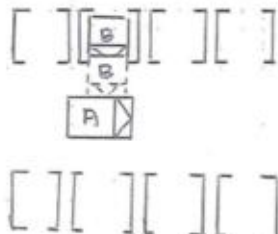

B: SKC1245H

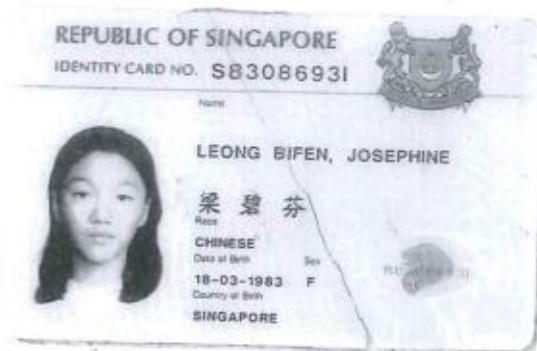
DESCRIBE CIRCUMSTANCES OF THE ACCIDENT
