

Brief Details.

On 1/11/2017, at about 7.25pm, while exiting PIE to Tampines Ave 5 and filtering into the right-most lane to turn into Tampines Ave 2, I had noticed a dark coloured, Nissan Qashqai, (SLB7560B) in the center rear view mirror, approaching at a fast speed towards me.

Suddenly the Qashgai overtook me and out angrily right across into my vehicle's path, causing me to brake and serve right to avoid a collision. I believe that this would be a case of road rage. The car had also slightly grazed against the front-left of my car, causing slight damage. The driver made no attempt to stop and render assistance after the collision.
