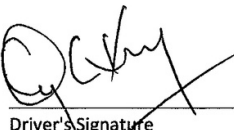

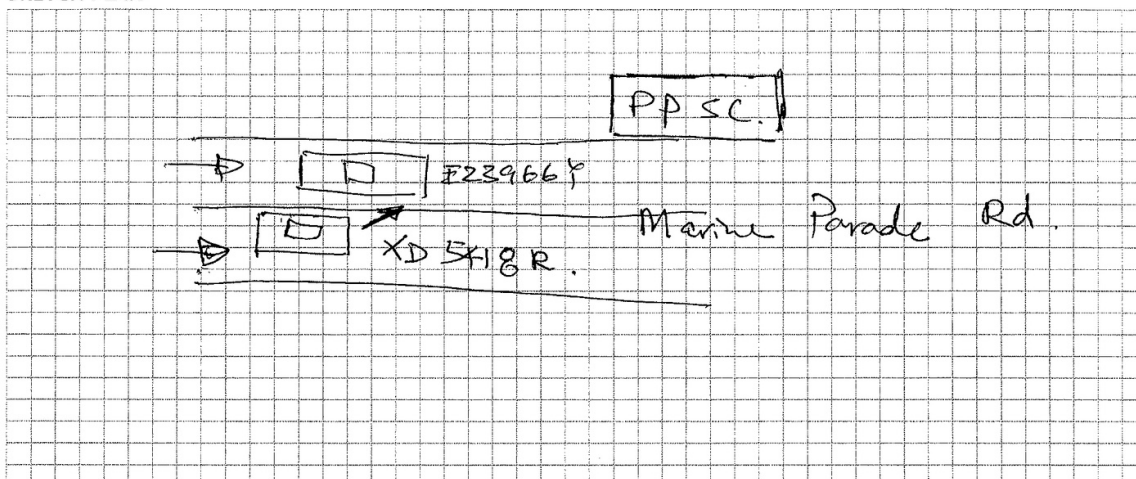

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

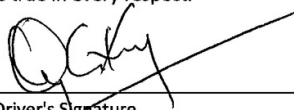
Time : 1440 hrs. (5-12-2017).
