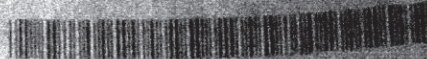

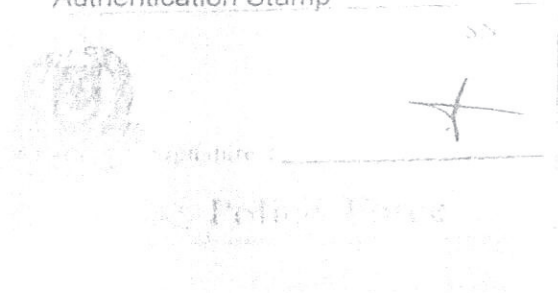
Brief details.
