**Brief Details.**

On 25/11/2017 at about 2020hrs, I was riding my motorbike bearing registration number: JSB7958 along AYE towards Tuas, along lane 1. While I was riding my motorbike near to penjuru exit one lorry bearing registration number: GBF3219L (C/O Sante pte.ltd) was travelling along lane 2 wanted to cut into lane 1 without signaling or checking for any oncoming vehicle.

Subsequently, the driver (GBF3219L) immediately cut into my lane due to that I didn't have enough time to engage my brake thus my motorbike front collided onto the lorry rear back. Due to the impact, I fell off from my motorbike, however the driver didn't came down from his vehicle. One of my witness namely: Jim Young Thin Fino who witness everything, approach the driver and informed the driver to come down from his vehicle. The witness then informed the driver to settle the matter. After which, we then exchange our contact within each other. The TP Officer was also at scene and he given us a TP report vide D/20171125/0138, and informed me to lodged a police report. The ambulance was at scene however I didn't wish to conveyed to hospital.

This is the first time such incident happened, I wish to state that I had suffered abrasion on my body, hand and leg, I had went to check-up at Malaysia and given me 01 week MC. I lodging this report for insurance claim.
