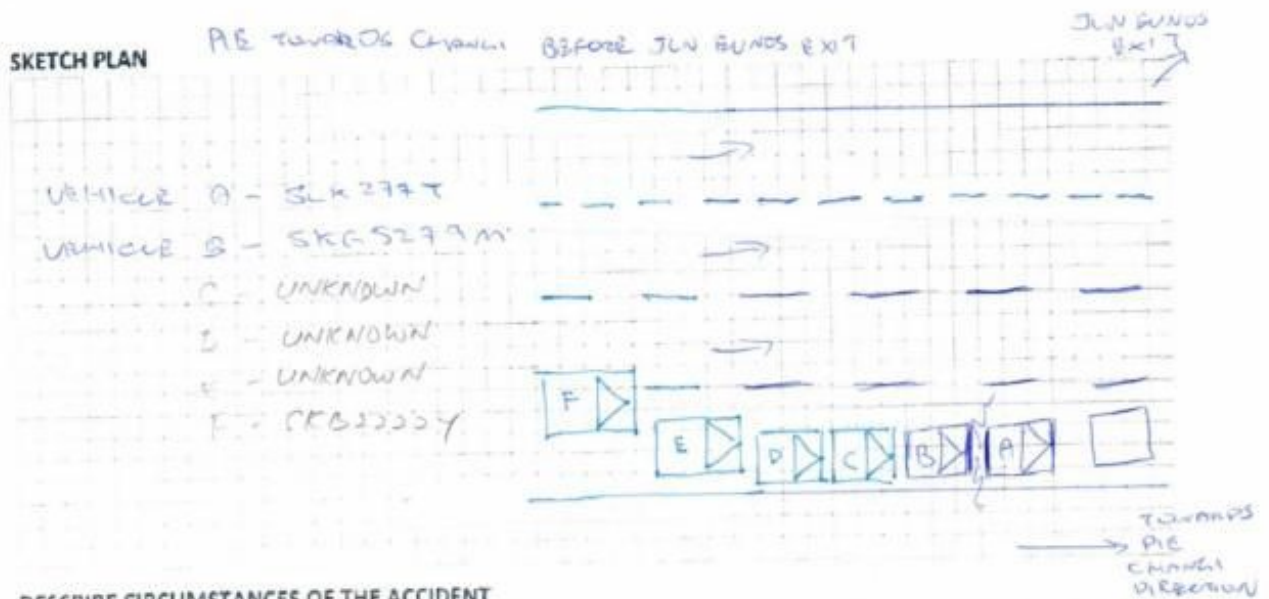

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I was driving on the extreme right lane of PE towards Changi.

while approaching Jln Bundo Exit, due to heavy traffic the vehicle in front brake to complete stop, and so I too applied brake to complete stop. Suddenly after a few seconds, I felt a great impact from the rear of my vehicle.

Alighted from my vehicle and realised a vehicle bearing (SKG 5279 M) collided to the rear of my vehicle. IT WAS A CHAIN COLLISION INVOLVING 6 VEHICLES.
