## ACCIDENT INVOLVING FBF 4085Z(OI) /SHF 513K(TP)/ OTHERS ON 06/12/2017

We refer to the above matter.

Third party reported that he was sending his passenger along PIR. He looked at the rear mirror, he saw OID lost control of his bike and collided onto third party taxi.

Our insured rider reported that he was riding on the  $2^{nd}$  lane of PIE towards changi airport. Suddenly SLJ 7018J who was travelling on his right changed lane and resulted the accident. The impact caused our insured rider to loose balance and thereafter he was thrown out of his motorbike and landed on the  $2^{nd}$  lane.

There was no video/witness statement from both parties.

We have contacted OID to verify the nature of accident. He was unable to confirm if his motorbike had hit onto third party taxi as he was unconscious after the collision.

We noted that police investigation result (PIR) shows that SLJ 7018J had been charged by traffic police.

In view of the above, kindly advise if we may re-direct the claim to the insurer of SLJ 7018J or else advise further instruction.
