Brief Details.

On 14/12/2017, my brother sent me a message regarding an accident that occurred on 27/11/2017 at about 1824hrs involving his vehicle bearing registration number SKF8429H.

My brother however was overseas during that period and I was the one driving the car. I could only remember briefly what happened. I was driving along Clementi Road on one of those days and as I was driving along the 1st lane, there were orange coloured construction barriers on my right side and at one point, it was cutting onto the 1st lane hence I checked my rear view mirrors to see if there are any upcoming cars and concurrently, I swerved slightly onto the 2nd lane to avoid collision with the barriers. I did not feel any impact or collision with any vehicle or motorist hence I continued on with my journey.

I have checked my brother's car did not suffer any damages. I would like to inform that I did not hit anything or anyone during that period to the best of my knowledge. My brother's car has an in built Camera inside however the records have been deleted automatically as it resets every few days.
