## Brief Details.

On 27/11/2017 at about 1823hrs, I was riding my vehicle, FQ4724H (V1) along Clementi Road towards Kent Ridge on the white line between lane 1 and lane 2. A Black Mercedes Ben (V3) is driving slightly ahead on my right side on lane 1, and a White Citroen C4 SGM3999Y (V2) is on lane 2 ahead of me as well. As I was approaching the traffic light junction near AYE exit along Clementi Road, me and V3 is approaching V2, when V3 suddenly swerved to the left. I perform emergency brake however V3 still hit me and the collision sent me flying towards V2. V3 however, continued on driving. I then stood up and pushed my bike to the road shoulder together with V2. I then exchanged particulars with V2.

Traffic police was at scene along with an ambulance. I was then conveyed to National University Hospital and was discharged on 27 November. I suffered abrasion on my left hip, shoulder and left pinky, and pain on my chest, back and left knee. I was given 5 days MC. There is no camera on my vehicle however there is an in-car camera on V2.
