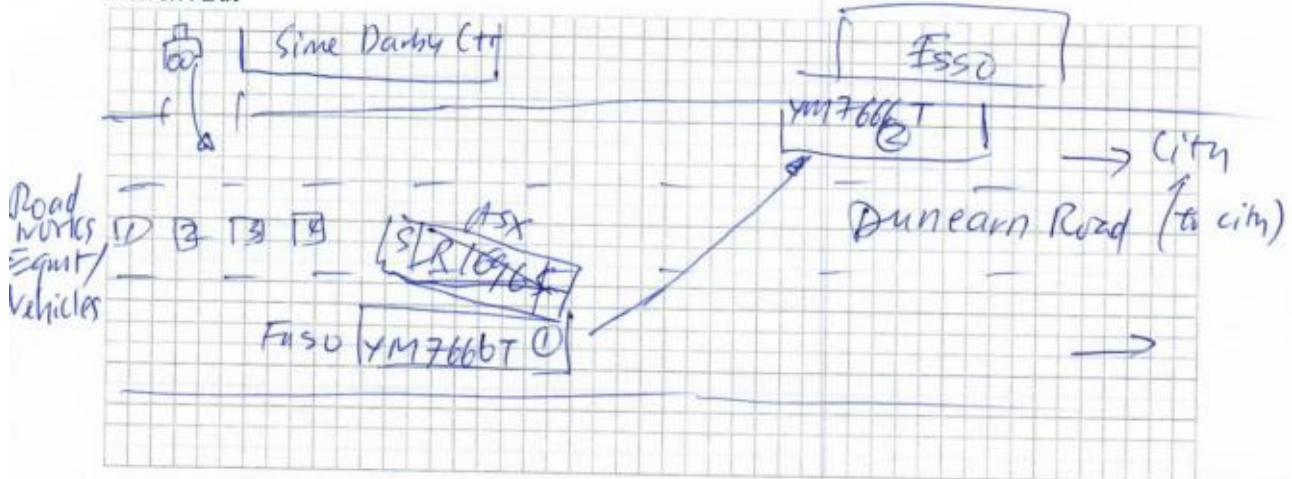

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

Just before 3pm on 7/12/17, my vehicle was waiting to come out from Sime Darby Centre at Duncarn Road (towards the city). I had stopped because there was vehicle traffic coming down on the left most lane, and pedestrians were walking from my right on the pavement. There were road works ongoing on the centre lane of Duncarn Road (towards city), to my right.

When I saw that the way was clear of traffic (left most lane) and pedestrians, I turned out and then made my way to the centre lane just beyond the road works area.

On the situation was unusual, I turned ^{my head} back to see between the road works vehicles (there were 3 or 4 of them) on the centre lane so as to gauge traffic.

In this awkward situation, I misjudged and accidentally strayed onto the right most lane. In that moment, the goods truck (YM 7666 T of SST'S Mover & Warehousing Pte Ltd driven by Tan Zhixiang) hit my vehicle. My vehicle was at the spot of the impact (pictures supplied) where it remained till it was towed away by tow truck (AA) despatched by
