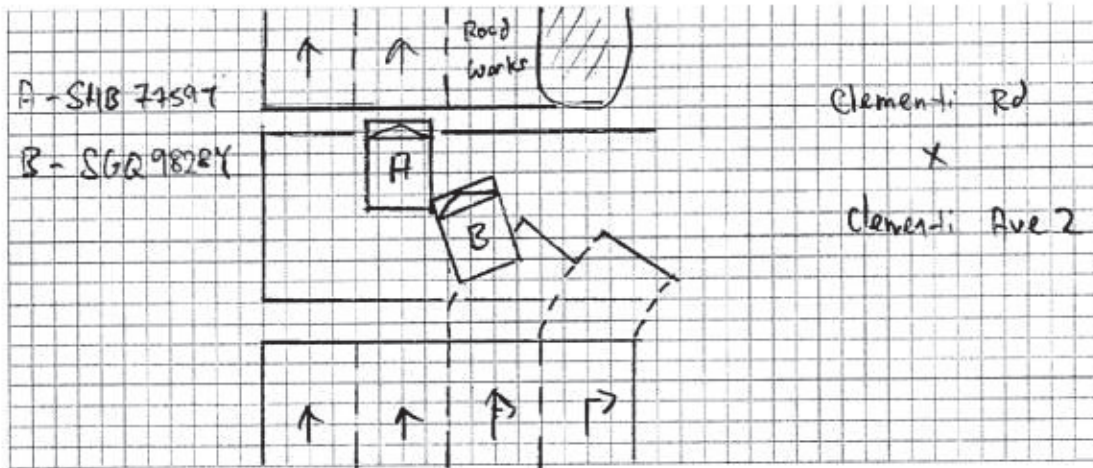

# Sketch Plan Pg. 1




