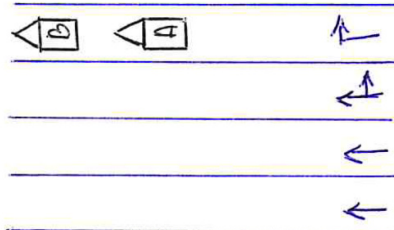



SKETCH PLAN

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 16/11/17 at about 1300hrs, my car bearing plate no: SLF7636X came to a standstill behind car B (about 1 car space) at Newton Circus traffic light junction (towards Bukit Timah City).

Subsequently owner of car B came out of his vehicle, went to inspect his rear ~~bumper~~ ^{bumper} bumper. He then ~~came~~ ^{then} came over and confronted me, I winded down right window and attended to him. He accused me of coming in contact with his rear bumper which did not happened. Due to owner B being intimidative and unreasonable, I told him to report to police and drove off. (He did not follow me).

At about 1525hrs, I made a trip to Bukit Merah West Neighbourhood police centre to lodge a report. Due to no damage on my vehicle, Owner B did not assault me, thus there was no case on my part and a formal police report cannot be lodged. Nevertheless, case was recorded under Station Diary bearing S/no: SD 42.
