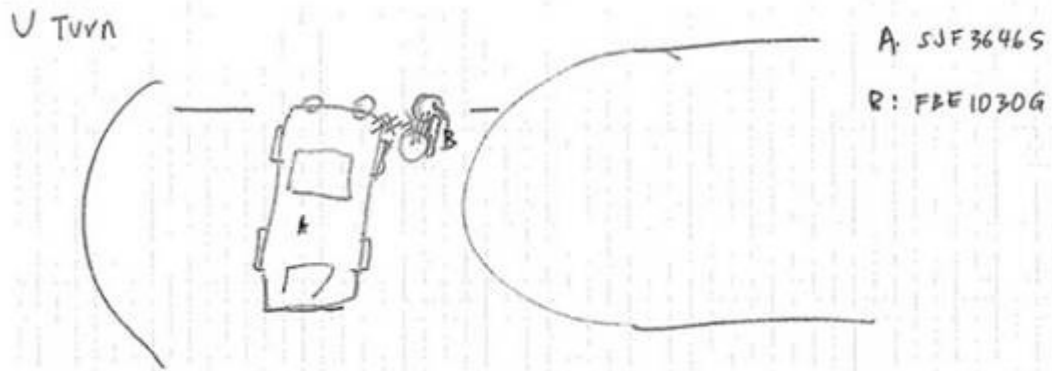
Please be informed that liability is **not clear** yet. There is no conclusive evidence yet to substantiate either party's version. Below is a copy of our insured's accident report for your perusal.
