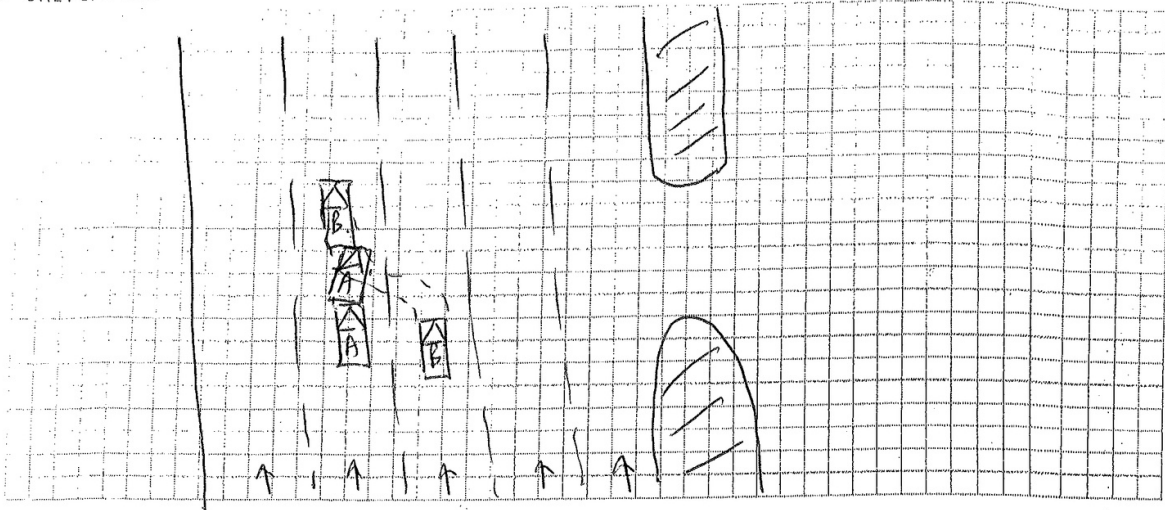

How the accident happen

1. Vehicle A, driven by me, has just turned out of Jalan Awang into Jalan Eunos and filtered into Lane ~~4~~ on a ~~4~~ lane Jalan Eunos towards the direction of East Coast Road with Lane 5 for cars making a U-turn to head into PIE.
2. Traffic was moderately heavy as there was a road work on the extreme right lane of Jalan Eunos.
3. Many vehicles were changing lanes from lane ~~4~~ into lanes ~~2~~ & 3 due to the road works ahead on extreme right.
4. There was about a 2-2.5 car length between me and the vehicle ahead of me as I was just about to pick up speed after coming into Jalan Eunos.
5. Vehicle B drove swiftly past me from my right in Lane 3 and cut straight into my Lane ~~2~~ to coming between Vehicle A and another vehicle in front of me, occupying up whatever gap there was originally, thereby reducing the safety distance.
6. Vehicle B thereafter jammed her brakes.
7. I then tried to swerve Vehicle A to the right into Lane 3 but could not as there were on-coming cars in lane 3, as seen from my right side mirror.
8. I then tried to jam my brakes and was able to stop Vehicle A but not without hitting the right side of the rear bumper of Vehicle B with the left side of Vehicle A.
9. Vehicle B driver then drove to the left side of the road and stopped her Vehicle B after Jalan Ismail.
10. Since all evidence of the accident has been void by vehicle B's driver driving off from the scene, I followed suit and parked behind her.
11. I questioned driver of Vehicle B on her actions of cutting the lane and why did she jammed her brakes, she said that she was in a hurry for work and blamed the driver in front of her for suddenly jamming the brakes which caused her to follow suit.
12. I am submitting an audio recording of our conversation for your reference, with driver to Vehicle B admission on point 11.

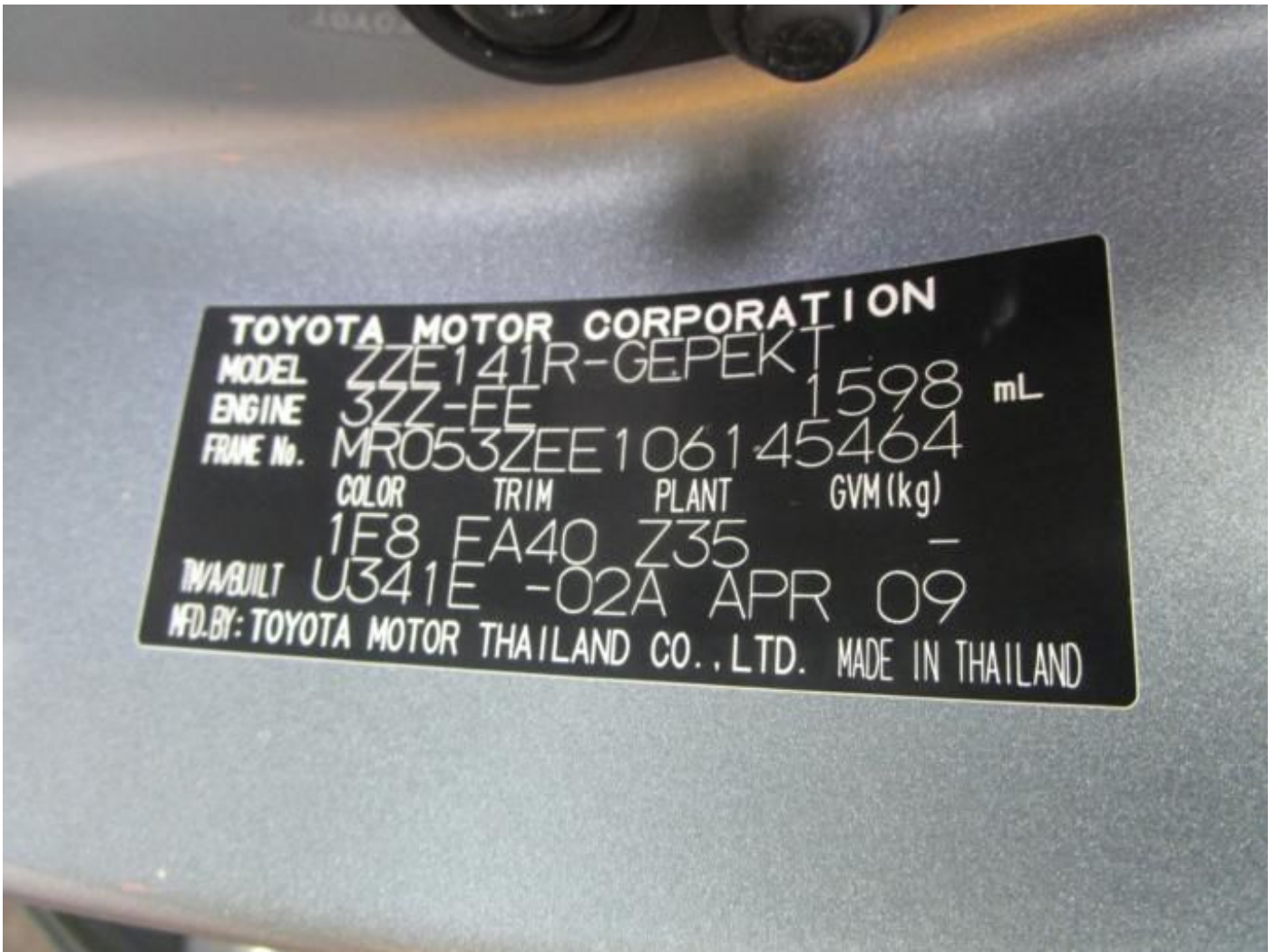
