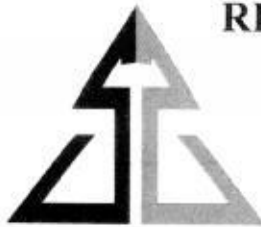
I am the owner of motor vehicle SKL 1409C which was involved in the above accident.
