#### MY ACCIDENT

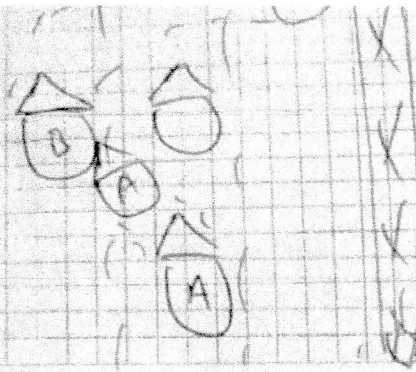
I am the owner of motor vehicle 3KL 1409C which was involved in the above accident.

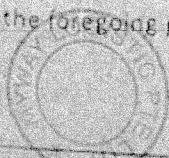
DESCRIBE CIRCUMSTANCES OF THE ACCIDENT
