



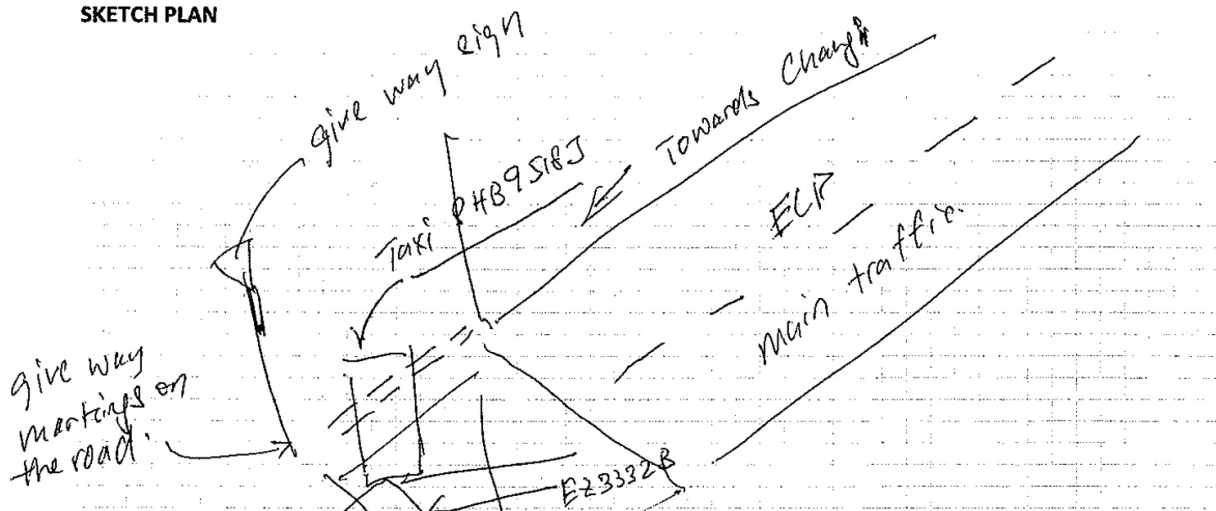

SKETCH PLAN





DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I was at the extreme right lane of the main road, ECP, and
near to Changi T2 with a filter lane to my right joining the main ECP.
This filter lane is a give way lane, meaning traffic from the filter lane
is supposed to give way to the cars coming from the main traffic from
ECP.
Upon approaching this junction, while I'm still on the right lane, I saw
a red taxi SHB9518J at the give way line. When I was about
just in front of SHB9518J, I saw him not move out of the and
beyond the give way line. While I tried to move away to give him space
to avoid a collision, he suddenly accelerated and hit my right rear of
the car.

SKETCH PLAN




