

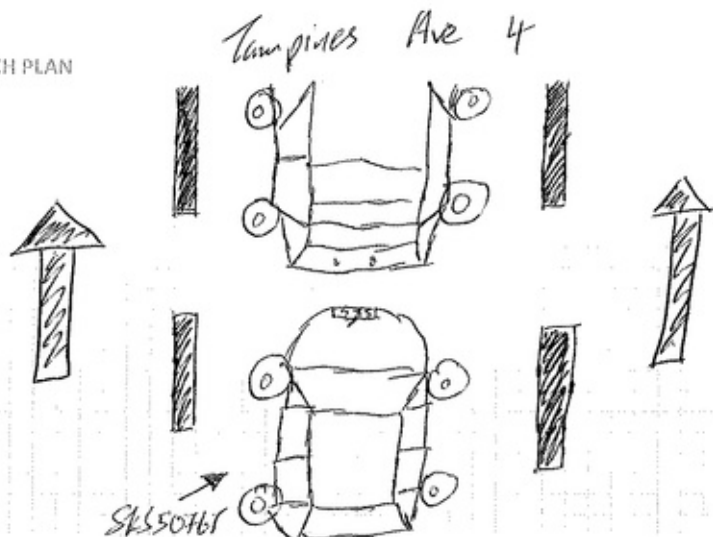

 it.




