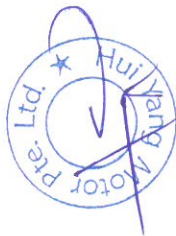

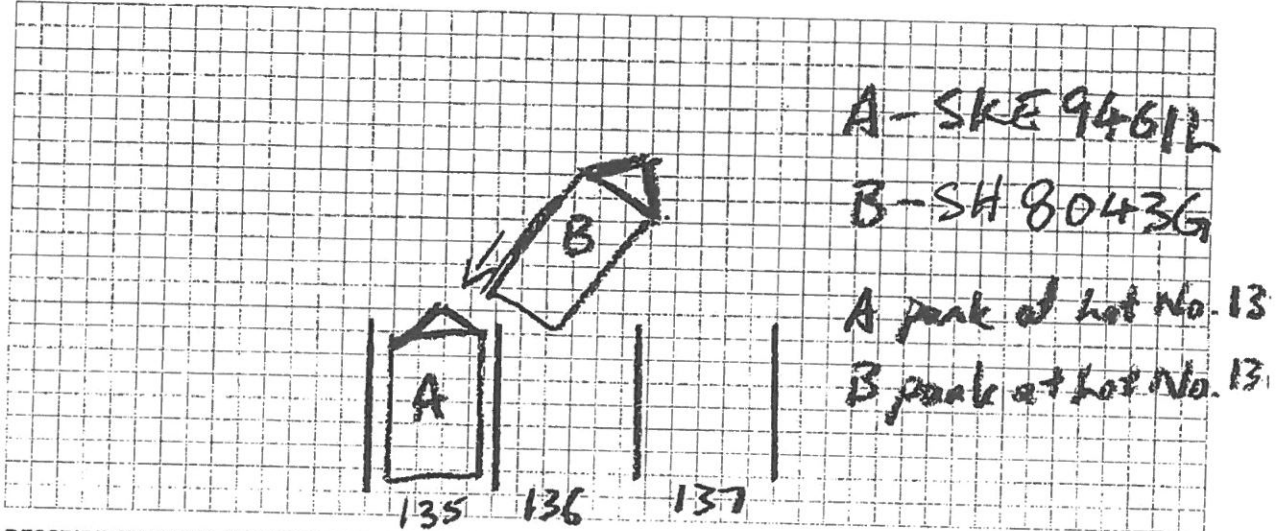

Brief Details.

On 16/12/17 at around 1940hr, I went to the above said location to retrieve my vehicle located at lot 135. We actually wish for private settlement however the driver kept on changing his side of his story. Therefore I summon for police assistance and the police advice me to lodge the accident report.
