### ACCIDENT STATEMENT

This morning (15/12/2017), I travelled on Woodlands Centre Road heading towards Marsiling Road without passenger in my taxi.

I moved at slow speed which was due to bottleneck traffic on the 2-lane road.

While I continued to move forward following closely behind others cars on lane 1 of the road, suddenly car B( SJJ 4329E), a white Honda and my taxi collided when the latter shifted to my lane from my left side after junction of Woodlands St 13.

I could not take evasive action to avoid car B as closely on my right side was the concrete centre divider.

I immediately took photos of car B following the accident which showed car B clearly encroached onto my lane which was the cause of the accident.

I found the left front portion of my taxi was dented while the right of car B sustained dents on the spot.
