



- ACCIDENT STATEMENT

Yesterday afternoon (14/12/2017), I moved off from Takashimaya after a male passenger boarded my taxi at the taxi stand.

It was bottleneck traffic on the driveway towards the exit and I kept the travelling path on the rightmost lane all the while.

While I followed closely behind other cars moving towards the main road (Orchard Turn), it was car B(SLG 3993K) that hit into my taxi amid shifting to my lane after exiting from the carpark exit on the left side of the driveway.

I immediately took photos of car B, a BMW, at the scene.

The impact inflicted slight damage to the left rear portion of my car.

There was a light dent to the front of car B.
