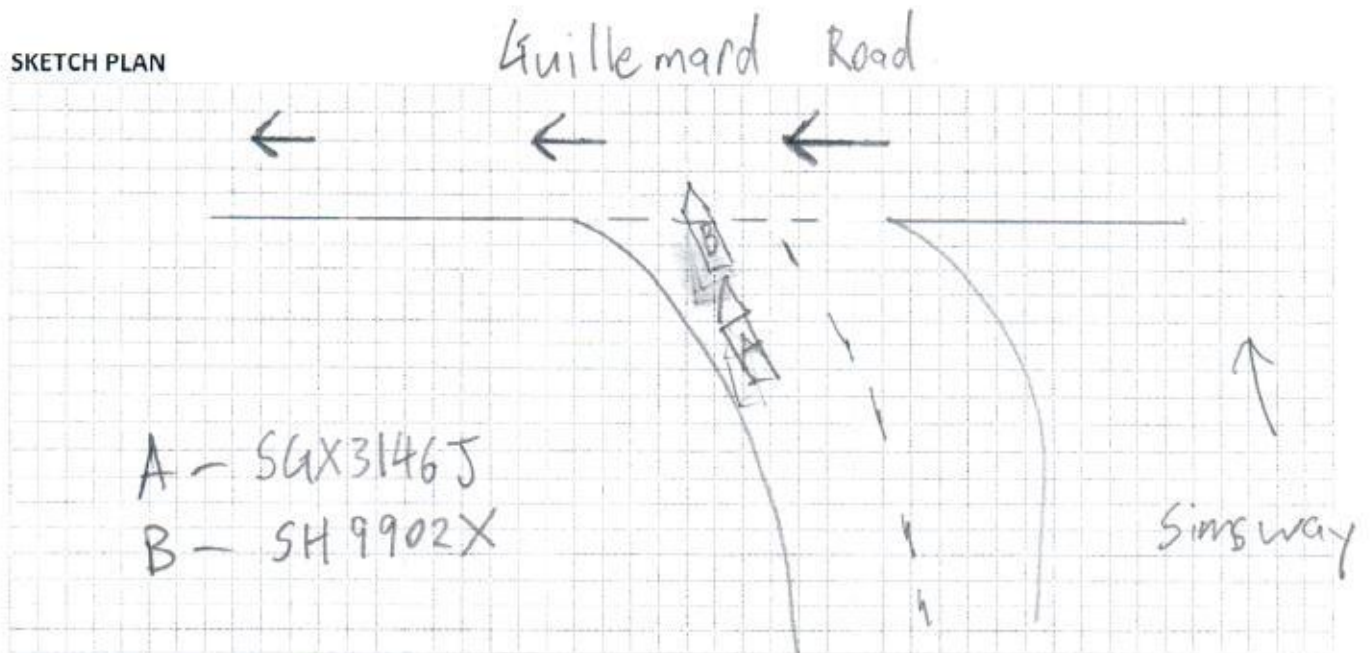

I wish to state that I have rented a car bearing number SGX3146J, Honda Stream blue in colour from Straits Credit & Leasing Pte Ltd No. 210 Turf Club Road, THE GRANDSTAND Lot B17 S(287995) from December 2017 till 11 August 2017.

I then immediately called my rental company to informed of the accident and I was not informed that I will need to pay the excess and the rental company will handle for me to settle with NTUC Income Insurance Company. I and the taxi driver then made a check on our vehicles damaged. The damages were scratched on the front hood and dents on the front bumper and bumper slight loose on the rental car and there was dents on the taxi rear bumper. We then came into conclusion to report to our respective insurance company.

On 26/10/2017, I received a letter from the NTUC Income company to state that they did not get any response and they can can't proceed further. I was advised to make a police report that because the taxi driver and passenger was reported injured during the accident.
