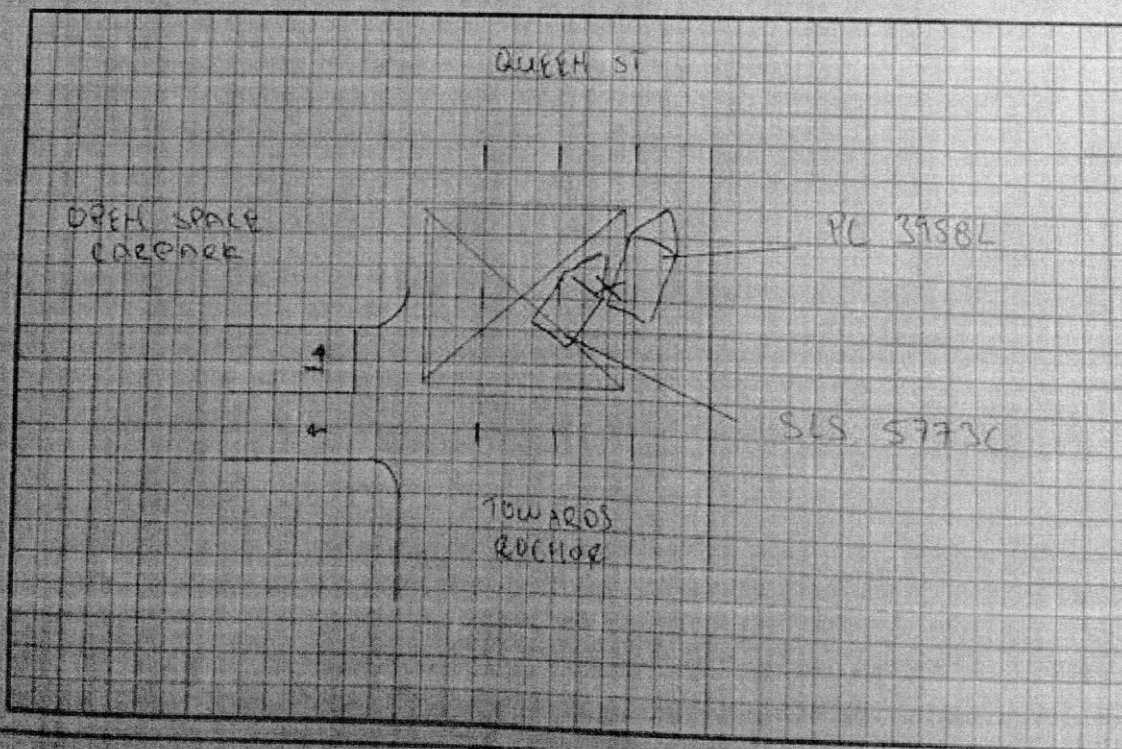

On 17th December 2017 at about 1530 hours, my vehicle SLS5773C was approaching the exit of car park adjacent to Queen's Street. After the traffic coming from my right was clear, I slowly moved onto Queen Street and slowly filter into the outer lane on the right (intention to turn right at junction of Queen's Street and Rochor Road. As I already move onto the lane 2 (see diagram), the outer most lane of YELLOW BOX JUNCTION, my car was suddenly hit by vehicle no. PL 39582 on the right side front fender. The said vehicle was behind me at the exit of the carpark (footage from my video camera).

The accident is recorded by my vehicle's camera (front and back).
