WITHOUT PREJUDICE

Since I last communicated with you a few months ago, I noted that there were no further developments. I was expecting to receive a reply from you stating the cost of repairs of the "damages" to SJL6300M. That was your advice.

I have made further investigations as regards the reported damages to the rear bumper of SJL6300M. In my investigations I visited several second hand car dealers and had the opportunity to carefully review many similar cars (model and make) how it was possible for "alledged damages" to be caused by my Mercedes car star-shaped badge on the front grill. In my view it was simply not possible.

In fact if you study the front of the car, you will notice that the car's license plate mounted on the bumper would have been the first to impact the rear bumper, and not the Mercedes Logo which is recessed as was alledged.

Furthermore I measured the relative height of the logo and the "top edge of the rear bumper" in the location as marked in your report. It is impossible for the logo to have made the damage - a slight indentation.

If the other party would like to proceed further, kindly inform them that I have retained the services of a lawyer to challenge their claim in the the court of law. It will also attract a counter suit for damages and costs.

To further protect my interest, I shall be submitting to my Underwriters a comprehensive report to refute the allegations. It is a matter of principle that I find it necessary to defend my interests as the liabilities of this case will affect my ability to enjoy my no claim bonus which I have carefully preserved over the years.

Kindly make the necessary representations to the involved parties, as needed.
