ACCIDENT INVOLVING VEHICLES SLU 8894G(OI) AND SHA 4042C(TP) ON 21/12/2017

We refer to the above matter.

TP reported that he proceeded to drive shortly after traffic light turned green in his favour when OI vehicle suddenly collided onto his vehicle. TP further reported that the OI beat the red traffic light which resulted in the collision. Enclosed copy of TP CCTV footage for your review.

OI reported that he was travelling along the left lane towards Orchard Road when TP vehicle suddenly collided onto his left portion of his vehicle. OI further stated that the traffic light was amber when he crossed the junction of Orchard Road and Scotts Road. OI has no CCTV footage to prove.

We had spoken to the Insured driver where he confirmed that at the material time, he was travelling at the said location as reported and mentioned that he was driving slowly across the junction. Furthermore, OI strongly disputed that the traffic light was in his favour upon crossing the junction when TP vehicle collided onto his middle portion of his vehicle. OI was informed about the possibility of a 50/50 settlement and disputed on the liability assessment as he believed his vehicle was already halfway across the junction.
