Circumstances of Accident

On 22.12.2017 at about 1915hrs, I was driving my vehicle (A: SLN8984S) at the 3rd lane along Woodlands Avenue 2. While I was travelling straight within my lane, I noticed my front vehicle (C: SGB5580R) stopped his vehicle. I followed suit. When my vehicle was stationary, a vehicle (B: GBG7035T) out of sudden hit onto the left rear portion of my vehicle. Upon alighted, the driver of vehicle C accused me for hitting the rear portion of his vehicle which I totally denied. I clarified with him that I had managed to stop in time without hitting his vehicle. The existing frontal damage was not related to this accident. After the accident, we moved our vehicles to a minor road to exchange particulars. Subsequently, I reversed my vehicle and accidentally hit onto the left front passenger's door of vehicle C while the door was opened. Vehicle A (SLN8984S) : No Passenger on board. Vehicle B (GBG7035T) : No Passenger on board. Vehicle C (SGB5580R) : 3 Passenger on board.

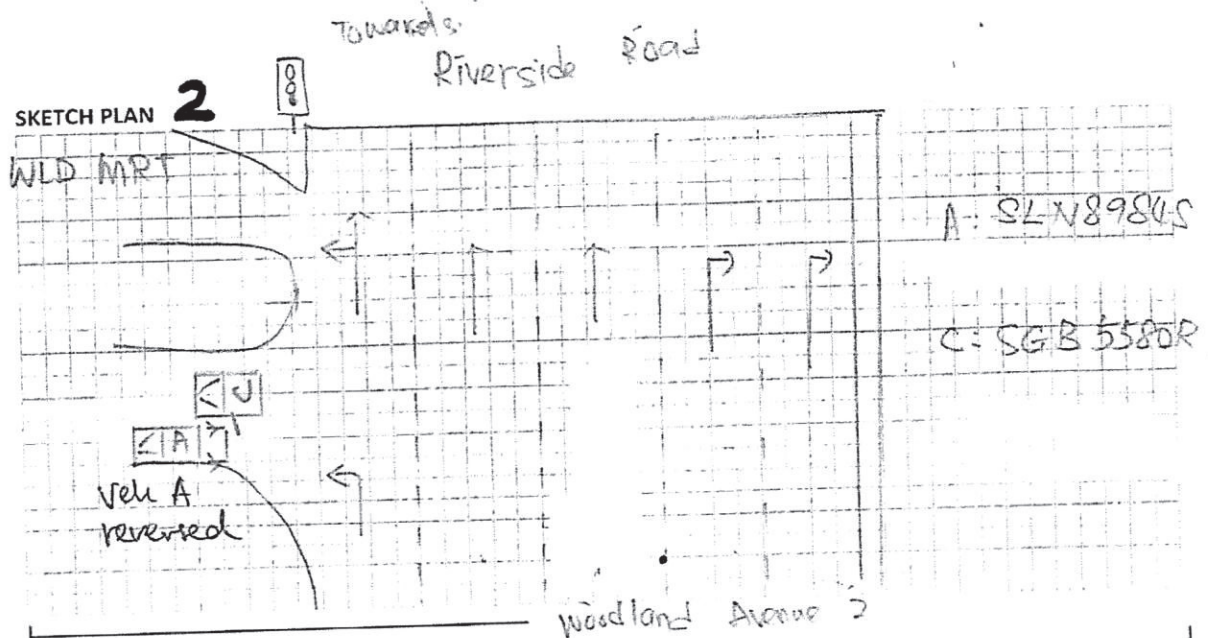
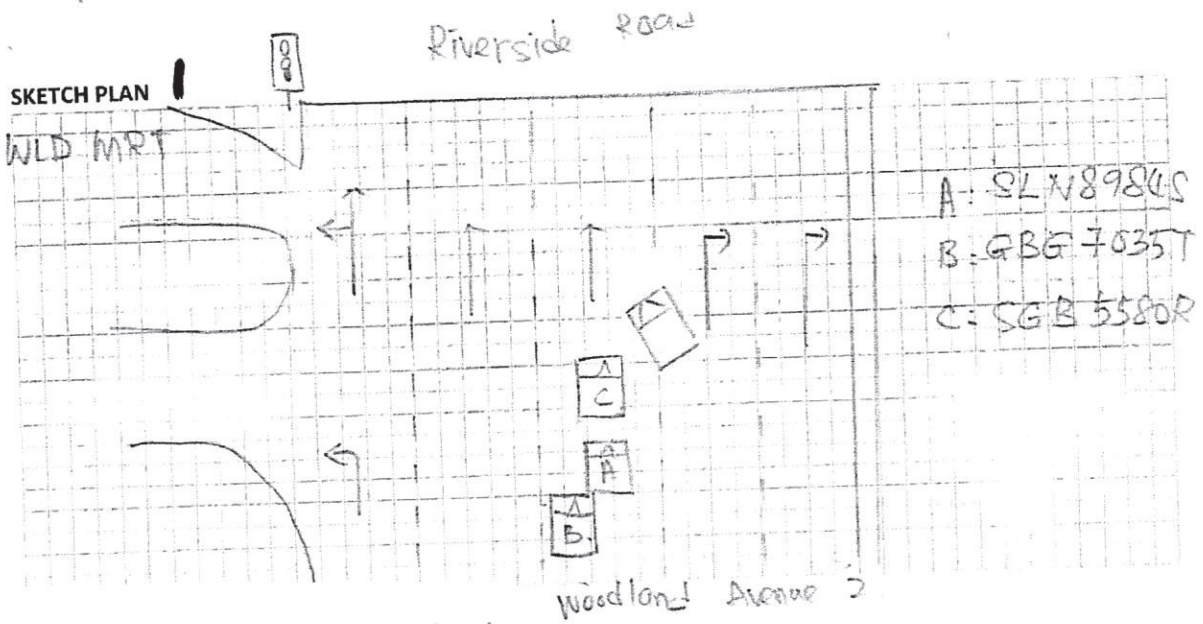
