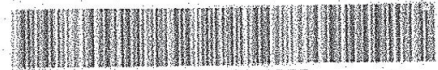

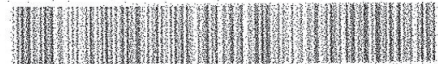
Brief Details.
