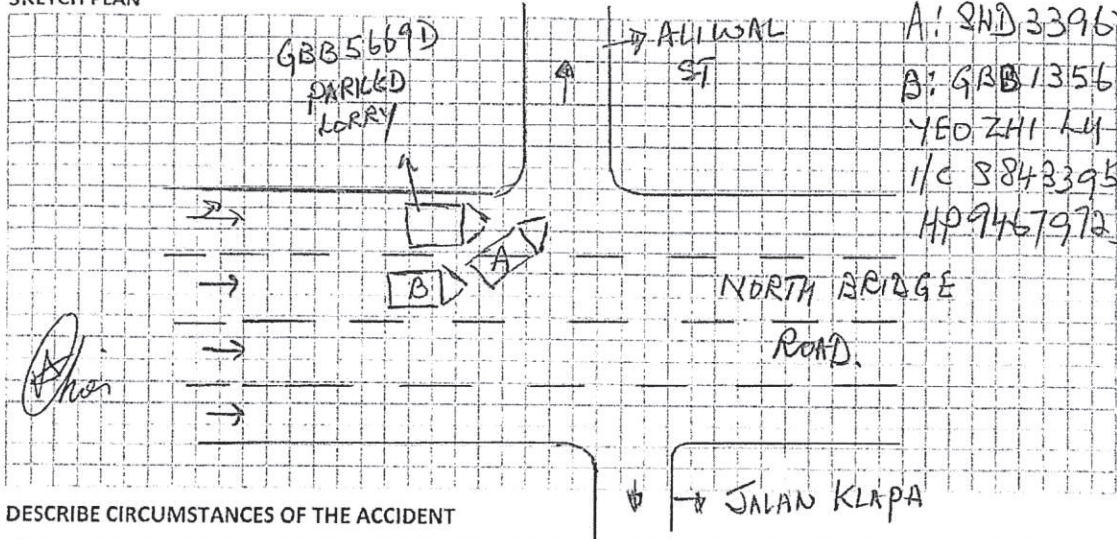

Describe Circumstances of the Incident

On 24 Dec 2017 at about 23:45 hrs I was driving straight on the second lane from the left along North Bridge Rd heading towards the direction of Aliwal St.

Somewhere before the junction of Aliwal St I noticed a parked lorry GBB5669D on the left lane along North Bridge Rd hence I drove along the second lane from the left as I intend to turn left towards Aliwal St at the same time switched on my left hand signal lights. Upon reaching the junction of Aliwal St I reduced my taxi speed to negotiate the left turn. At the point of turning left suddenly a van ^{H. B}GBD1356H came from behind collided onto the Rear Portion of my taxi.
