We refer to our earlier conversation.

We have interviewed the Insured Driver and a copy of his statement is attached for your reference.

Circumstances

He was travelling alone along Commonwealth Avenue and stopped before the junction of North Buona Vista Road.

He stopped about ½ car's length behind the Third Party Vehicle and was stationary for about 1 to 2 minutes. During this time, the gear lever was in 'Drive' position while the brake pedal was depressed.

At this point, he heard a 'swoosh' sound followed by a sudden flash of fire on his body, hands and face. Thereafter, he realized that the Insured Vehicle was moving forward despite the brake pedal was depressed.

Thereafter, the front portion of the Insured Vehicle slightly 'touched' the Third Party Vehicle. He frantically attempted to open the door and wind down all the windows when the Third Party Driver alighted and started taking photographs.

The Insured Driver advised the Third Party Driver that the Insured Vehicle is on fire and told him to move away. He subsequently alighted and sat at the side of the road when he felt extreme burning sensation to his body and arms. He also advised that his hair was also burnt.

Thereafter, the SCDF officers who were already at scene were putting out the fire when the Insured Driver heard 2 explosion sound.

Injury

The Insured Driver advised that he suffered burns on his face, upper right limb and left limbs (Discharge Summary refers).

He was subsequently conveyed to NUH together with the SCDF officer who was injured while putting out the fire and an unknown male Malay in his 40's who was hit by debris due to the explosion. This male Malay is believed to be a motorcyclist who was nearby the scene.

Based on various news article, it was reported that 4 men were injured due to the accident.

We have contacted IO Raziz (6547 6200) to establish the injury details for the involved parties but he declined to comment on this matter as investigation is still ongoing.

We have already applied for the Traffic Police reports of the Third Parties and shall forward a copy to Insurers if any.

'following preliminary investigations, the Singapore Civil Defence Force (SCDF) said both CNG taxi fires occurred due to the leakage of compressed natural gas within the vehicles, which was then ignited by the lighting of cigarettes'.

The Insured Driver advised that he is a smoker but does not smoke in his vehicle.

We will be applying for the SCDF Fire Report and also establish the full particulars of the injured parties.

I have inspected the insured vehicle last Friday at the premises of Transcab. My comments are set out below.

The insured vehicle was severely burnt at its rear and centre portion along with its interior compartment. The fire damage was less severe at the front portion with parts inside the engine compartment sustaining mainly heat damage.

From various media reports and videos that were uploaded, the explosion was after the insured vehicle was engulfed in flames. The explosion was likely due to sudden venting to atmosphere of the compressed gas inside the 2 CNG tanks located at the rear boot floor of the insured vehicle.

I will be primarily focusing on the original cause of the fire to the insured vehicle and my preliminary assessment is that the cause was due to electrical nature after the insured vehicle had rear end the TP vehicle. The original of fire was inside the interior compartment of the insured vehicle. Live wires may have become loose and shorted to ground upon coming into contact with the metal body causing sparks, which may have landed onto combustible materials inside the interior compartment, igniting a fire.

Of notable interest, is the scene photo that was taken and attached in the TP GIA report. I have since managed to obtain a soft copy of this photo. Upon zooming in on the photo, the front windscreen of your insured vehicle was noted to be dislodged. The roof panel was also bent with damage to the driver's door and inner trims. Such extent of damage to the insured vehicle does not appear to correspond to the damage to the TP vehicle as seen in TP GIA report.

It is also noted that the damage to the front bumper of your insured vehicle was relatively minor and there was no buckling or impact damage to the front bonnet of your insured vehicle. However I did observed that there appears to be a windscreen on the road surface beneath the rear portion of the TP vehicle. Attached is the scene photo that I had managed to obtain from Premium Automobile for your reference.

Your insured driver's narration of the events leading up to the accident is crucial to establish the causation of such extent of damage. Since Deen will be conducting the interview with your insured driver, I will communicate with him on some questions which your insured driver should clarify.

On a separate, I was informed that the Police have seized the SD card from a camera that was mounted on the TP vehicle (subject to confirmation on whether it was the rear view camera of the front view camera). Once it has been returned to the owner, I will be requesting to have sight of the video recording.

My full report will follow thereafter.

We shall continue to touch base with him to establish further.

Meanwhile we have contacted the 3P Driver who advised that he was stationary for quite some time when the Insured Vehicle rear ended him.

Upon alighting, he approached the Insured Driver who advised that he was experiencing chest pain and felt unwell.

After assisting the Insured Driver out, he was alerted by a passerby that smoke was emitting out from the Insured Vehicle.

He confirmed that he noticed smoke was emitting out from the rear left portion of the Insured Vehicle and subsequently followed by the fire.

He further advised that all these occurred within a span of less than 10 minutes.

He also advised that apart from the SCDF officer and the Insured Driver who were conveyed to the hospital, there were no other person injured in the accident.

The Third Party Driver confirmed with us that he was not injured due to the accident.

We will be following up with the Insured Driver to record his statement and update Insurers in due course.
