We have reviewed the accident scenario and we are of the view that the lobby entrance to Novotel Hotel Singapore is a two lane road and TP vehicle has the right to travel on the left of our insured vehicle as there is another pathway which TP can travel on.

In the video, our insured stopped to change lane to his left to the lane to his left which in turn collided with TP's vehicle. Hence, our view that this should be BOLA 15 instead against our insured driver.
