collided into her vehicle. Whereas the third party m/bus driver alleged that our Insured suddenly cut into his lane whilst he was moving.

Based on the video screenshots provided by third party m/bus, we noted that Insured had stopped near the traffic light to drop off a passenger and the third party m/bus

collided into the Insured vehicle that was stationary at the traffic light after dropping off a passenger.

We are of the view that the third party driver should have ensured proper lookout before moving from bus stop and Insured driver should not have stopped at bus lane to alight passengers even after noticing the third party m/bus at the bus stop because by stopping, Insured vehicle had obstructed the bus movement at the bus lane during peak hours.
