According to surveyor, photos 18-26 show the damaged front door lock and rear door glass regulator gear.

At time of assessment, the rear door glass regulator gear was working intermittently.

For this model, the door lock can be electronically controlled. Please see photo attached.

During the survey, the door lock could not be activated when the lock sensor was touched.
