Meanwhile, kindly forward to us with **any evidence (if any)** your client have to support your claim.

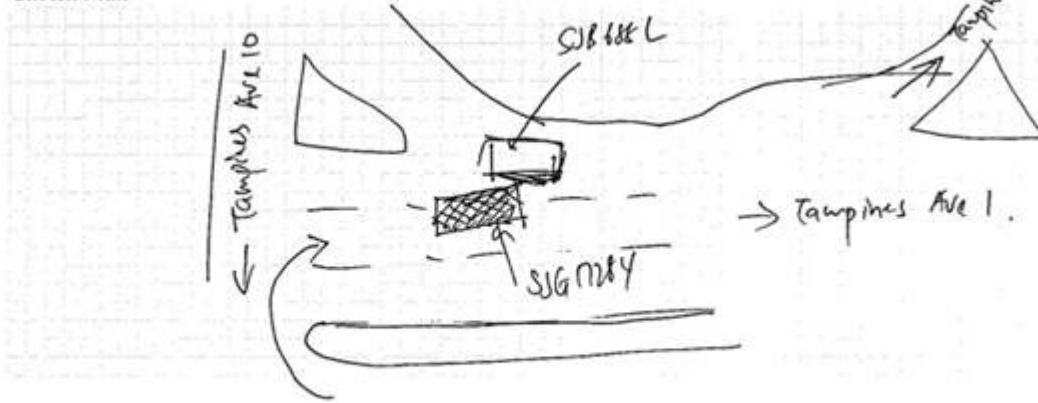

#### Describe Circumstances of the Accident

- Time of accident was around 10:35hrs on 22 Dec 2017, weather condition was very bad.
- Vehicle SJG 688L was travelling on Tampines Ave 10 and turning into the slip road going to Tampines Ave 1.
- While ~~about~~ exiting the slip road (into Tampines Ave 1) ~~it~~ collided with just U-turned vehicle no: SJG 1728Y.
- During the accident, the ~~the~~ weather was very bad as it was pouring very heavily.
- Road condition was also very wet.
- Photograph of the location of ~~the~~ accident were taken.
- Owner named Mr Lim was the driver of vehicle SJG 1728Y the car was a ~~the~~ private hired car (as there was a private hired car decal sticker on the wind screen of the car).
