Sorry to disturb you on this case as we need your kind assistance.

Our client SKP 1845 H vehicle has been surveyed by LKK Kenneth and there was no prices given at that time as Volvo parts prices are not readily available and also many parts need to order, as such we do not have prices during survey time.
