Brief Details.

On 21/12/2017 at about 0845hrs I was driving my bus (PA9570S) along SLE on the left-most lane of the 3 lane road. At this juncture, while I was nearing the entrance from Woodlands Ave 2, the lorry (YN8903Y) in-front of me jammed brake due to a vehicle filtering from Woodlands Ave 2. Due to this I was unable to brake in time, as a result my bus collided onto the lorry.

Subsequently both vehicles stopped on the spot and we alighted to checked on the impact of the collision. I observed that one of the passenger of the lorry at the back portion was injured on the left-side of his head, the wound was seen bleeding. The lorry driver then called for ambulance who then arrived afterwards with the police.

My bus front side was dented and myself was not injured. The lorry's rear cover was also dented. Subsequently the police at scene then took down the particulars of the lorry driver and the injured passenger. I wish to state that I did not managed to take down their details. I was issued a case card reference to J/20171221/0076 under TP IO Shikin, Off: 6547 6439 and was advised to lodge a police report.
